Explanation:

The annual income and expenditure accounts of these organizations were mostly analogous: money came in through similar routes (legacies, donations, interest on investments), and was spent on similar things (overheads, advertising, printing literature). However, differences in reporting standards within and between organizations often results in data that can't meaningfully be compared. For

example, organizations often carry over any surplus between their annual income and expenditure accounts to the opposite account in order to bring the two sides into agreement, but this standard bookkeeping practice obscures actual figures. All the groups discussed here balanced their accounts in this way in at least some years. Similarly, a single line item that is an expense and also produces income might be balanced on one side of the accounts. Literature, for example, costs money to print and mail but produces revenue when it is sold. In most cases the costs and revenue associated with that line item were reported separately in the appropriate accounts. But some organizations, in some years, balanced items like these on one side of their income and expenditure statement. That is, if the organization spent more on printing literature than it made selling it, it might record under expenditures the cost of printing minus the revenue it produced, with just the difference added in to the total expenditure. The Vegetarian Society did this for a number of line items in certain years, the effect of which was to skew their actual income and expenditure, sometimes by thousands of pounds, thus making external comparisons with other organizations and internal comparisons over different years much less useful. Finally, organizations might alter what was considered annual income from year to year. For example, the VS included its cash reserves in its annual income accounts from 1950 through 1955 – no other organization recorded their cash holdings in this way, nor did the VS after 1955. The VS also posted legacies it received from 1956 to 1976 to its general fund account rather than to its annual income. Mysteriously, the NSACS published a financial statement for the year 1949 but then also combined figures for 1949 and 1950 in its statement for 1950. These figures were adjusted to facilitate more accurate comparisons between and within organizations: Appendices G through K show the adjustments that have been made.

In some cases it was not possible to adjust figures to correct inconsistencies, as when organizations presented a balanced line-item in a statement without revealing the figures used to calculate it. The NAVS published only the net amount it received from income and investments from 1950 to 1955; from the interest of its deposit account, 1952 to 1955; and the difference between the income tax it paid and the amount it recovered from 1956 to 1965. The BUAV reported just its net losses on the sale of fixed assets in 1964 and 1965. The LACS showed only the net amount of dividends it received in 1954, from 1962 to 1966, and then again from 1973 to 1976. The NSACS printed just the net amount it raised at the Animals' Fair. These figures had to stand as printed. It was also not possible to adjust for differences in the calendars used for reporting. Annual financial reporting tends to follow either the calendar year, January to December, or the standard financial year of April to March. In each year of this period the NAVS, LACS, and NSACS used the calendar year. The BUAV used a near approximation of the fiscal year from 1950 to 1957 – May to April – then changed to the standard financial year for 1959. Its report for 1958, the year of the switch, therefore covers only eleven months of activity, from May to March. The Vegetarian Society changed its financial reporting year five times in this period. From 1950 to 1955, its reporting year is September to August; from 1956 to 1960, June to May; from 1960 to 1968, January to December; and from 1971 to 1976, July to June. In the years in which the reporting range changes, its annual statements reflect less than a full twelve months' activity. Each of its annual accounts for 1956, 1957, and 1970 cover only nine months, and there are two reports for 1960, one covering the twelve months from June 1959 to May 1960 and the second covering the seven months between June 1960 and December 1960.

For simplicity, each organization's annual statement of accounts is treated as if it covers twelve months' activity, and as if it adheres to the calendar year (so a report covering August 1953 through

April 1954 would be treated as an annual report for 1954). Likewise, when figures are adjusted for inflation, these have been adjusted to the calendar year in which the report ends regardless of the precise dates of reporting. Finally, I was unable to locate the annual accounts of the BUAV for 1969 and 1973, of the NSACS for several years, and of the VS for the months from June to August 1956 and January through September 1969. When three-year averages are employed in figures here, adjustments were made to account for this missing data. Given these challenges, complete synchronicity and accuracy is impossible; therefore, these figures should be regarded as valuable for the overall picture that they convey, but as less reliable for short periods in particular organizations.
